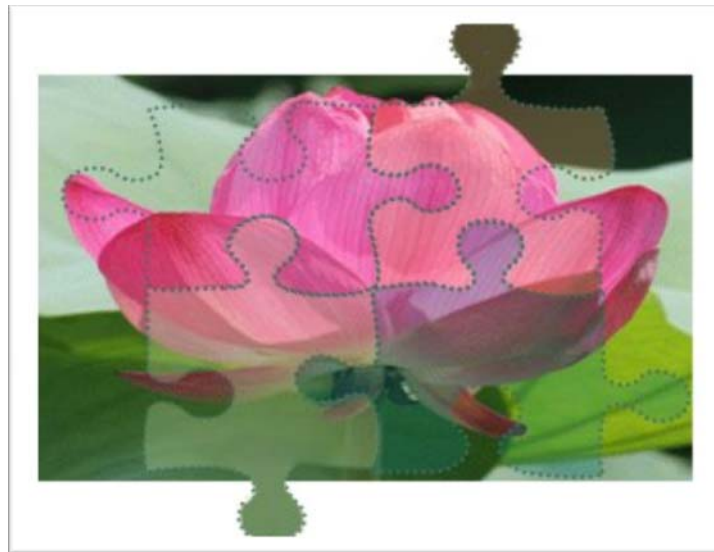

## Keynote Speaker:

### Patricia Murphy, PhD, APN



Pat Murphy, Ph.D., APN is an advanced practice nurse for bereavement and ethics. Dr. Murphy received her doctorate in nursing research from NYU and completed a fellowship in health care ethics at Georgetown University. She is board certified in advance psychiatric nursing by ANCC and in Thanatology by the Association for Death Education and Counseling.

She has been working in the inner city with dying and grieving people for more than 30 years. Dr. Murphy has published extensively on issues in sudden loss, bereavement, ethics and palliative care and is recognized nationally as an expert in these areas. She co-chairs the hospital's bioethics consultation service. Drs. Murphy and Mosenthal shared a recent Faculty Scholar award by the Soros Foundation's Project on Death in America. Their fellowship project was "Integrating Palliative Care on an Inner City Trauma Service." Since 2002 they have been implementing a RWJ Foundation grant (one of only 4 in the country) called "Interdisciplinary Model for Palliative Care in the Trauma/Surgical ICU". Also, in 2005 she received a grant from the AETNA Foundation to integrate palliative care in ICU.
