Dr. Sally Norton a faculty member at the University of Rochester where she is Associate Professor in the Elaine C. Hubbard Center for Nursing Research on Aging, School of Nursing; Co-Director of Research and Performance Improvement, Palliative Care Division, Dept. of Medicine; Associate Professor, Division of Medical Humanities and Clinical Ethics; and Associate Professor of Family medicine in the School of Medicine and Dentistry. She has received numerous awards for her leadership work in Palliative Care and is Principal or Co-Investigator on numerous grants. Dr. Norton is recognized for her published work, particularly in Communication at End of Life and more recently as a prominent member of the AAHPM/HPNA “Measuring What Matters” Project.

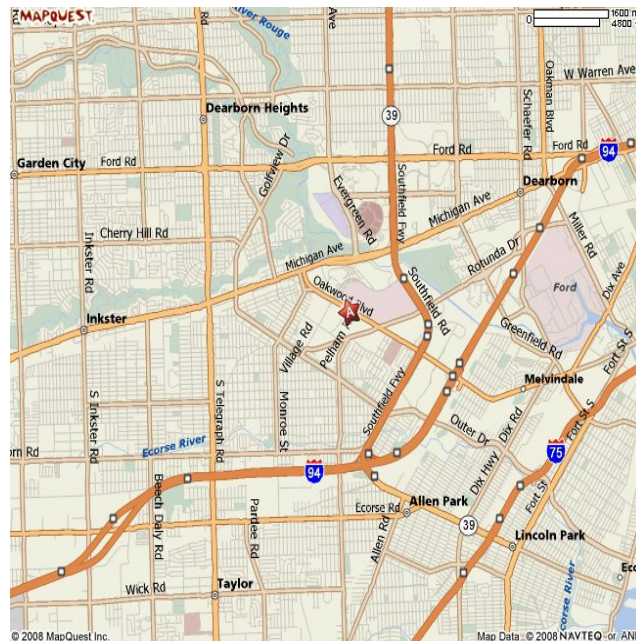
